
From the Grand Professional Alchemist


Fraternal Memories from GH Mitch Levings:

In the Constitution & Bylaws of the Alpha Chi Sigma Fraternity, the very first Bylaw states, *“Discrimination based on race, religion, sex, ethnicity, national origin, age, disability, veteran status, sexual orientation, gender expression, or gender identity is prohibited”*. That seems to be a pretty all-inclusive, common sense statement, but it has taken multiple revisions over multiple decades to get to that lofty declaration. In its early

days, Alpha Chi Sigma followed the template of nearly all Greek letter societies and restricted its membership to men who were "non-Semitic members of the Caucasian race". By the mid-1940s it had become obvious that membership restrictions were denying membership to a number of very talented Jewish chemists, and the chapters were wanting change. On November 21, 1947, the University of Colorado (home to Eta Chapter) Board of Regents adopted the Policy on Discriminatory Membership Requirements, giving all student organizations five years to open their membership to all students. The matter was taken up at the 1948 Conclave, where there were numerous, heated debates on how to change the Bylaw. Many delegates didn't want to stop at removing the non-Semitic portion, but wanted removal of the Caucasian requirement as well (It would take another eleven biennia before the male only requirement was challenged). The debates went long and passionate, as Conclave debates are prone to do, and by the end of the parliamentary maneuvering, the restrictive clause was reworded to "socially acceptable", and the whole matter was referred to committee. The Supreme Council thought they had bought some time to resolve the matter, but the delegate from Alpha Zeta Chapter at M.I.T was so dissatisfied with the way the Conclave handled membership qualifications that on November 18, 1948, with much fanfare and publicity, Alpha Zeta Chapter voluntary returned their charter to the Grand Chapter. News of this action spread around the country with articles appearing in publications such as the Chicago Tribune, Los Angeles Times, New York Sun and others. A headline in the Nov. 19, 1948 Boston Herald stated, "M.I.T. Fraternity Resigns in Racial Protest". Unhappy with the negative publicity, the Membership Standards Committee, under the direction of GPA Merle Griffin worked with the chapters and universities to hammer out a membership qualification that met the needs of everyone. Membership qualifications were reworded at the 1950 and 1952 Conclaves. At Colorado, the five year grace period expired and, the Board of Regents held a review. The Board did not feel Alpha Chi Sigma's latest effort went far enough, so on January 14, 1953, the Committee ordered Eta Chapter to disband. It took more than a year of appeals and hearings, but the Board of Regents finally allowed Eta Chapter to reactivate on March 22, 1954. After the 1954 Conclave, racial restrictions were out of the Alpha Chi Sigma Bylaws, but many chapters were at universities that remained segregated until the late 1960s. It would be 30 years before Alpha Zeta returned to the active chapter roll on April 30, 1978. The current nondiscrimination Bylaw seems like the perfect position statement. . . for now. We've thought that before.

Professional Brother Spotlight

Omar Yaghi (Beta Omega '94), Susumu Kitagawa, and Richard Robson were awarded the Nobel Prize in Chemistry in 2025. These scientists designed molecular structures with large internal spaces that allow gases and other substances to pass through. These structures, known as metal-organic frameworks (MOFs), have a wide range of applications — from collecting water from desert air and capturing carbon dioxide to storing harmful gases and speeding up chemical reactions.
