Committees

DEI Committee

Committees Created by Conclave Legislation

Motion 32

Motion text: In order to create a learning opportunity for the fraternity, the GMA is to appoint a committee to explore the opportunity for subordinate chapters and individual members that have faced corrective actions to opt into a final report to be made available to the rest of the Grand Chapter that discusses the infraction that initiated the corrective action in question and/or the actions that brought them back to chapters/ members in good standing. This exploration is to be reported out by the summer SC meeting in 2025 for implementation as early as the following school year.

This committee has been established, with OA Kip Nally serving as Chair. I have nothing specific to report as of yet; the committee is still in the early stages of its task. I am confident that the committee will meet the timeline established within the motion.

Motion 33

Motion text: The Supreme Council shall form a committee to make recommendations for modifications to the Health and Safety policy to better serve our collegiate and professional members. The committee will report the recommendations to the Supreme Council no later than the first winter SC meeting in the 58th Biennium. The committee shall consist of, at minimum, one member of the OA who will chair the committee, one active professional member from a housing corporation, one collegiate member, and two other brothers, who will be selected by the Grand Master Alchemist. Brothers interested in serving on the committee should submit their names no later than August 1. The Grand Master Alchemist will appoint the committee by Aug 15, 2024. The Supreme Council will report the recommendations and any changes to the Health and Safety policy to the Grand Chapter at the 58th Biennial Conclave.
