The End of an Era

of Alpha Chi Sigma

n Feb. 28, I leaned back in my chair after signing the final documents that transferred ownership of the James F. Miller National Headquarters Building at 2141 N. Franklin Road to a woman who will run a home healthcare business from the location. It had been the Fraternity's national headquarters for more than 30 years, but it was bigger than our current needs, the neighborhood was declining and costs were increasing.

After suffering two thefts of the building's air conditioners and the county clerk's office billing us for property taxes for the first time, we began assessing the cost of relocating in 2011. The numbers showed that if we could relocate into a smaller property, we could save the Fraternity a few thousand dollars a year.

For about a year, not much happened. Our real estate agent was unable to identify a suitable property in a better neighborhood. Then in August 2013, we found a property that would work. It previously was a dentist's office. It was on the very small end of the size we thought would work,

controlled storage or to be sold. We had to consult with our architect to determine the new layout. Carpet, lights, furniture and wall colors were

but it was in a good neighborhood and it would be easy to renovate to give it a modern and efficient layout.

The staff performed heroically sorting, boxing and labeling things for moving to the new office, moving to climate

selected, and the contractors went to work. The government shutdown in the fall slightly delayed getting the contracts we needed, but we were in the new office by the end of December.

The old building took a while to sell, but that all finally came to fruition and we started this month without the burden of an oversized building in need of constant maintenance and security.

The whole process was a reminder to me that change is sometimes tough and the uncertainty can be stressful but focusing on why change is necessary and the desired outcome can bring tremendous improvement. That reminds me that I need to keep up the efforts to improve my diet and overall health.

If you see needs within our Fraternity or a better future if we institute some changes, let me know. Conclave is coming up at the end of July and if you give me your ideas as soon as possible, I can distribute them to the Grand Chapter for discussion and consideration before Conclave.

Supreme Council nomination procedure

In addition to receiving nominations from the Nominations Committee, the Constitution and Bylaws allow for Grand Chapter members to nominate candidates prior to Conclave. Here is the process we will follow for nominations prior to Conclave:

- 1. The Nominator and Seconder will notify the Grand Recorder in writing of their nomination of a Supreme Council candidate.
- 2. Within three days of receipt of a nomination and seconding, the Grand Recorder will determine if the nominee is an active professional member and will contact the nominee to determine if he or she accepts the nomination.
- Nominees whose nominations are received and accepted before Conclave will be invited to submit their vita and statement of views to be posted on the website and available to members of the Grand Chapter at Conclave.

4. Nominations from the Grand Chapter received and accepted before March 30 will be invited to submit their vita and statement of views to be included in the April issue of *The Chrome and Blue*, which also will include the nominees from the Nominations Committee.

Nominations also will be accepted from the floor at Conclave.

Delegate elections

An official Call to Conclave and a Notice of Delegate Election Form has been sent to all collegiate chapters, professional chapters and colonies. The Delegate Election Form is due to the National Office by April 14.

Legíslatíon

Conclave sessions run more smoothly and accomplish more if there is legislation in the hopper before Conclave starts. This gives delegates time to research the issues and seek input from their Brothers. If you intend to make a resolution or amendment to the Constitution and Bylaws, contact <u>Grand Recorder</u> <u>Patrick Johanns</u> by April 24.

Don't lose your tax-exempt status



College and professional chapters whose gross receipts are normally \$50,000 or less are required to file annually an electronic Form 990-N with the IRS.

The form is easy to complete. All you need is the following information about your organization:

- Employer identification number (EIN)
- Tax year
- Legal name and mailing address

- Any other names the organization uses
- Name and address of a principal officer (chapter advisor)
- Website address, if the organization has one
- Confirmation that the organization's annual gross receipts are normally \$50,000 or less
- If applicable, a statement that the organization has terminated or is terminating (going out of business)

Get more information from the IRS.

The National Office e-mailed instructions to chapter treasurers on March 13. If you have any questions, contact the <u>National Office</u>.

The e-postcard is due each year by the 15th day of the fifth month after the close of your tax year. For Alpha Chi Sigma, our tax year ends on Dec. 31, so your e-postcard is due by May 15 each year.

Don't put Alpha Chi Sigma's or your chapter's tax-exempt status in jeopardy!

Collegiate chapter reminders

Member registers

The National Office will e-mail the collegiate chapter member registers the week of March 31.

The registers will be e-mailed to reporters and master alchemists. Please review your chapter's register carefully and send any additions or corrections to the <u>National Office</u> by June 15.

Professional Branch Induction

Professional Branch Induction (PBI) transfers a member from the collegiate branch to the professional branch.

Collegiate chapters should send their <u>PBI forms</u> to the <u>National Office</u>, even if you don't have a Professional Induction Ceremony.

Annual reports

Do not wait until May or June to submit your chapter reports. The <u>officer list, CRRI</u> form, chapter plan and audit can be submitted when completed.

Take note – All reports due June 15!

Alcohol awareness training: Learning from other chapters' experiences

If your chapter is struggling with your annual training, you're not alone. But there are several chapters that have had successful training programs. We recently asked master alchemists from these chapters to tell about their experiences and provide some suggestions for other chapters. Here is what some of them said:

How easy or difficult was it to plan the training for your chapter?


Stress the importance of alcohol awareness training. Even if some people don't drink or have sat through many discussions on the matter at hand, it is still important and necessary.

What you need to know about Star Chapter Award criteria

To qualify for the One-Star Chapter Award, a chapter each academic year beginning July 1 and ending June 15 must:

- Return all pledge and initiation reports and fees to the National Office on time.
- Initiate a minimum of eight or 1/3 of the number of current active collegiate members (reported in the preceding year's Active Collegiate Member Register).
- Conduct two major service or professional activities. The report submitted to the National Office must include a description of the activity, the date, the number of Brothers involved and the estimated total number of people involved.
- Submit an officer list within two weeks of each election.
- Complete alcohol awareness training and return the sign-in sheet to the National Office by June 15. At least 10

Brothers or pledges must attend the training, including the chapter's Master Alchemist, Vice Master Alchemist, Master of Ceremonies, Treasurer and any social chairs.

- Submit the following reports by June 15 each year:
 - Star Chapter Annual Report of Chapter Activities
 - Audit/Financial Statement
 - Charter, Ritual and Regalia Inspection (CRRI) Report
 - Active Collegiate
 Member Register

To qualify for the Three-Star Chapter Award, a chapter each academic year beginning July 1 and ending June 15 must:

- Satisfy all of the requirements for the One-Star Chapter Award.
- omplete alcohol awareness training and return the sign-in sheet to the National Office by June 15. At least 75 percent of your chapter's members (including pledges) must attend the training, including the chapter's Master Alchemist, Vice Master Alchemist, Master of Ceremonies, Treasurer and any social chairs.
- Maintain a chapter Web page, which must include:
 - Information about pledging and membership

- A current calendar of events
- The current chapter and officer contact information
- Professional and service activities
- An active link to the National Web site
- Plus accomplish any four of the following:
 - Increase active collegiate members by 5 percent (based on the preceding year's Active Collegiate Member Register).
 - Conduct two additional major professional or service activities.
 - Conduct two alumnirelated activities.
 - Conduct one additional major professional or service activity and one alumni-related activity.
 - Submit a Professional Branch Induction Report.
 - Submit one or more nominations for a National fraternity recognition award (such as the Scholar Award, the Ronald T. Pflaum Outstanding Chapter Advisor Award and the John R. Kuebler Award).
 - Submit a Chapter Plan for the year.
 - Maintain and submit a current copy of the chapter's bylaws to the National Office.




Delta Gamma Chapter installation at Georgia Southern University


As of March 14, all chapters have done a great job submitting initiation paperwork and/or payments on time for spring 2014. Thank you and keep up the good work!
